

GoodLife Fitness Clubs Discounted Membership Agreement

In consideration of The Interior Designers of Canada ("IDC") providing the IDC member listed above and his/her eligible family members listed below (together, "Member") with access to GoodLife Fitness Clubs ("GoodLife") discounted membership program ("Program") during the Term, and other good and valid consideration the receipt and sufficiency of which is hereby acknowledged, the Member hereby represents, warrants, and agrees as follows:

1. The GoodLife All Club membership entitles Participants to the following:
 - (a) All Participants will have access to all GoodLife Fitness Clubs locations for the Term.
 - (b) Extra services such as Personal Training require additional fees. Upgrades must take place at the facilities and a separate agreement must be signed by the Participant directly with the GoodLife Club.
 - (c) An **Idc - Interior Designers of Canada** member must be a member of GoodLife before their other family members may join under this program. GoodLife reserves the right to cancel the program should the company not follow this parameter of the program.
2. The Member must pay the entire annual registration fee (or pro rata proportion thereof in the event the Member joins during the Term) prior to being eligible to enroll in the Program.
3. The Member must complete and sign a GoodLife registration form at the Member's GoodLife facility of choice before being allowed to pick up the Member's GoodLife membership card or gain access to a GoodLife facility.
4. The Member must at all times fully comply with all rules and regulations applicable at the respective GoodLife facility. The Member's GoodLife membership may be immediately cancelled, at the sole discretion of GoodLife, upon violation of any such rule or regulation.
5. In order to maintain its eligibility for the Program, the Member must at all times be an IDC member in good standing, or be an eligible family member of an IDC member in good standing, failing which the Member's GoodLife membership will be immediately cancelled.

6. IDC is not responsible for the acts or omissions of GoodLife or Members in using GoodLife facilities. The Member will not claim against or seek damages from IDC arising from the Member's participation in the Program or use of a GoodLife Facility.
7. The Member's eligibility for the Program is conditional upon IDC qualifying as a member of GoodLife's Key Account Partner Program, including all minimum number of Program participant requirements. Should IDC cease to be a qualifying member of GoodLife's Key Account Partner Program, or should the minimum number of Program participants not be maintained, the Member's membership may be immediately terminated without prior notice.
8. By signing this Agreement, the Member agrees to pay IDC all sums, fees, and charges as required pursuant to the Program when due, irrespective of the amount of use the Member makes of GoodLife facilities.
9. No refunds are permitted under this Agreement for any reason and memberships cannot be put on hold.
10. IDC Members enter into the Agreement with GoodLife at their own risk and IDC is not responsible or accountable for anything with respect to the Agreement and IDC in no way guarantees payment of the amounts due by an IDC Member.
11. By signing this agreement, the IDC member acknowledges that GoodLife cannot take any action against IDC with respect to the IDC Member's Agreement with GoodLife.
